Your institute is granted provisional affiliation to Aryabhatta Knowledge University, Patna on the following terms & conditions:-

3. This provisional affiliation is subject to the condition of submit the approval letter of Bihar Nurse Registration Council, Patna.
4. This provisional affiliation is subject to the condition of deposit of Endowment Fee ₹2,50,000/- (Two Lakh Fifty Thousand only) per Course i.e. ₹2,50,000/- (Two Lakh Fifty Thousand only) in any Nationalized/scheduled bank branch as Fixed Deposit in the name of College and the said FD will be pledged in favour of the Registrar, Aryabhatta Knowledge University, Patna. A Xerox copy of the FD duly attested by the Principal of the college will be send to the University by means of the letter within a week from the date of receipt of this letter, failing which this letter will be automatically treated as withdrawn.
5. This provisional affiliation is subject to attending all the deficiencies/ Shortcoming/ advices/ suggestions/ remarks pointed out by the Inspection team in its report dated 22-02-2020 (copy attached) and to inform the university through affidavit about the removal of all the deficiencies and fulfilment of other conditions as pointed out in the inspection report under reference within a period of 60 (Sixty) days.
6. This provisional affiliation is subject to deposit requisite/dues fee of the University.
7. The University may inspect your college at any working day without information.
8. All minutes of Governing Body should be submitted to office of Aryabhatta Knowledge University, Patna at the earliest.
9. When any vacant post will be filled by the college/institute, University representative should be invited. Any appointments must be done in presence of University representative.
